SPECIAL REPORT TO THE COMMUNITY

Public Comment included thanks to Dr. Kahn for his leadership during the past 18-months, welcome message to Dr. River-Lacey, the telecommuting cost reimbursement policy and process, and reflections on an in-person outreach event.

Board Vice President Evilsizer shared a press release from the Chancellor's Office related to the additional one-time funding that is being allocated to community colleges. He acknowledged Dr. Kahn's work as Interim Superintendent/President, welcomed Dr. Rivera-Lacey, and congratulated the faculty
