# SPECIAL REPORT TO THE COMMUNITY

Public comments from the August 8, 2023, Governing Board thanked the Governing Board for improving the custodial working conditions and wages. There were concerns regarding the MOU telecommute for employees and how there was late notice provided by the District due to employees having to work onsite two weeks prior to the fall semester and two weeks after the fall semester begins. Further, there were expressed concerns regarding the 2025-2026 COLA not being guaranteed to the classified employees contract.
