SPECIAL REPORT TO THE COMMUNITY

Public comments from the September 12, 2023, Regular Governing Board meeting included expressed concerns regarding the approval of Resolution No. 23-21647 not being unanimous consent by the Governing Board. Additionally, it was shared the classified employee unit has low morale due to vacant positions not being filled. Another expressed concern was mentioned about the adopted budget for fiscal year 2023-2024. The budget book was not reviewed through shared governance nor the Budget Committee. It was recommended in the future for transparency that the budget be shared in advance prior to the Governing Board's approval for input.

Student Trustee Wass shared he attend Club Rush on September 12, 2023, and hopes to increase club activity for the Inter-Club Council. He shared the Associated Student Government is having a retreat from September 15, 2023, through September 16, 2023.

Trustee Schaeg shared she attend Plenary and expressed her excitement for the fall semester. She thanked Dr. Rivera-Lacey for the continuous updates regarding the storm impacts and the start of the fall semester. She attend the A Step Beyond Event and will be participating in a skill assessment through the Nursing Education Department at Palomar College.

Trustee Patacsil shared she is looking forward to the fall semester at Palomar College. She attended the College Plenary. She discussed Palomar College looking into a Native American Indigenous Student Success grant and has been working with elected officials regarding the California Ed Summit.

Trustee Rodriguez thanked Dr. Rivera-Lacey for her continuous communication regarding the start of the fall semester. He attended the College Plenary, the SDICCCA Board Alliance Meeting, and the A Step Beyond Event.

- Approve Fiscal Year 2023-2024 Budget
- The District requests the Governing Board to appoint Kathryn Kovrig as the Member-At-Large Representative for a two-year term on the Independent Citizen's Oversight Committee.
- Rescind Resolution No. 21-21645, previously approved at the July 11, 2023, Board meeting, which authorized certain layoffs, as the positions have secured funding.
- Adopt Resolution No. 23-21651 authorizing investigation of feasibility of funding sources.
