President Miyamoto thanked the trustees for their nomination and election as the Board President. She stated her focus will remain on student success. Trustee Miyamoto mentioned her attendance at the virtual Community College League of California (CCLC) conference and her appreciation in doing so. She recognized the many retirees and thanked them for their service. Trustee Miyamoto closed by saluting Palomar College students and those who serve students, and wished them all continued success.

Vice President Roberto Rodriguez recognized the resilience of the District over the last year. He also thanked the employees for establishing and implementing the important work around Diversity, Equity, and Inclusion (DEI) this past year. Trustee Rodriguez stated his gratitude for Dr. Rivera-Lacey's continued work in both internal and external relations and thanked everyone for their commitment to achieving 2021 goals and objectives. In closing, he wished everyone a happy holiday season.

Secretary Kartik Raju stated his appreciation of the openness and willingness of all employees to meet and educate him on the many initiatives within the District. Trustee Alazar encouraged the administration to consider wi-fi improvements throughout the campus and an improved food court for Spring semester.

Superintendent/President Dr. Star Rivera-Lacey stated her gratitude to the Governing Board for their dedicated and active service to the College and to employees for their unrelenting focus on supporting the success of Palomar students. She recognized the many donors who have committed funds to support our students through the Palomar College Foundation. ## At its meeting on December 14, 2021 the Board of Trustees:

- ratified one Memorandum of Understanding (MOU) between the District and CCE, and three Memorandum of Understanding between the District and PFF.
- ratified hourly rates of pay for short-term and student employees to comply with the California minimum wage increase, effective January 1, 2022.
- ratified the California Community College Quarterly Financial Status Report FY 21/22 CCFS-311Q.
- approved an agreement with Chabot-Las Positas Community College District for a grant from the California Department of Education for the purpose of operating an Early Childhood Mentor Program with other California Community Colleges.
