The Governing Board of the Palomar Community College District will hold a Board meeting on **March 14, 2017, at 5:00 p.m.**, at the Student Services Center, Governing Board Room (SSC-1) in the San Marcos campus, 1140 West Mission Road, San Marcos, CA, to consider an **amendment to the 2022 Facilities Master Plan**, 2010 Update, May 2010 to accommodate construction of the new parking structure and the new Maintenance and Operations Complex in San Marcos Campus and revise the location of the proposed new Campus Police Building ("Project"). The Governing Board will also consider adopting Addendum 1 and Addendum 2 to the previously certified San Marcos Facilities Master Plan Program Environmental Impact Report ("PEIR"), SCH No. 2008071024, under the State California Environmental Quality Act Guidelines Section 15164(a).
