Class specifications are intended to present a descriptive list of the range of duties performed by employees in the class. Specifications are not intended to reflect all duties performed by individual positions.

JOB SUMMARY.

Provides lead work direction, guidance and training to Plumbers and other Facilities personnel; performs the full range of Plumber duties in the design, installation, maintenance and repair of plumbing and related water systems, fixtures and equipment.

DISTINGUISHING CHARACTERISTICS.

Lead Plumber is distinguished from Plumber by its responsibility for providing lead work direction, guidance and training to plumbers and other designated employees in addition to performing the full range of plumber duties.

ESSENTIAL AND MARGINAL FUNCTION STATEMENTS.

Essential Functions: Essential responsibilities and duties may include, but are not limited to, the following:

- Participates in training and provides day-to-day lead work direction to other Plumbers; assists in assigning work; ensures conformance with District, department and code standards; monitors work flow to assist in ensuring that mandated deadlines are met; provides information, guidance and training on work procedures; assists in maintaining a fair and open work environment in accordance with the District's commitment to teamwork, mutual trust and respect.
- 2. Designs, installs, maintains and repairs plumbing systems in accordance with applicable building codes.
- Installs, maintains, repairs and services structural plumbing equipment including pumps, motors, valves, boilers, cooling towers, faucets, toilets, drinking fountains, fire sprinkler systems, water and sewer lines, washing machines and dryers, kitchen appliances and restroom facilities; repairs and replaces plumbing controls on kitchen and boiler equipment.
- 4. Installs and upgrades fixtures and equipment; repairs and replaces valves; lays out, installs and maintains plumbing systems; installs and tests backflow devices.
- 5. Repairs water and gas leaks in service lines; replaces polyvinyl chloride (PVC), copper and galvanized pipes; cuts and threads pipes; solders and sweats copper joints/fittings; rebuilds faucets; repairs water supply pipes.
- 6. Repairs and replaces plumbing fixtures, water heaters, pumps, valves and plumbing control devices, gas lines and meters.
- 7. Clears drains and obstructions in water and sewer systems; conducts pressure tests of water, gas and compressed air piping and systems; works from blueprints, diagrams, sketches and isometric drawings.

- 8. Ensures work complies with applicable plumbing and building codes.
- 9. Maintains a variety of records related to work performed and materials used, including job estimates, blueprints, sketches, diagrams and logs.
- 10. Operates and maintains a variety of tools and equipment including backhoes, skip loaders, trench diggers, jackhammers, drills, saws, pipe snakes, pipe threading machines, hand and power tools, water chemistry test kits, and testing and calibration equipment.

Marginal Functions:

- 1. Assists other Facilities personnel in cooperative assignments.
- 2. Performs related duties and responsibilities as required.

QUALIFICATIONS.

Experience and Education/Training Guidelines: Any combination of experience and training that would likely provide the required knowledge and abilities is qualifying. A typical way to obtain the knowledge and abilities would be:

Experience: Five years of journey-level experience in the plumbing trade.

Education/Training: Equivalent to completion of the twelfth grade.

Licenses/Certificates:

Possession of, or ability to obtain, an appropriate, valid California driver's license by time of appointment.

Knowledge of:

- 1. Specialized tools, materials, practices and methods used in skilled plumbing repair and the installation/maintenance of general plumbing systems.
- 2. Applicable building, plumbing and hazardous materials codes and ordinances.
- 3. Operational characteristics of plumbing, water, sewer and gas systems.
- 4. Backflow protection methods, practices and devices.
- 5. Health and safety regulations applicable to assigned areas of responsibility.
- 6. Technical aspects of the plumbing field.

Skill in:

- 1. Assigning and inspecting the work of lower-level employees.
- 2. Performing skilled, journey-level plumbing in the maintenance and repair of water systems and fixtures.
- 3. Diagnosing malfunctions and correct plumbing deficiencies.
- 4. Using a variety of tools and equipment specific to the plumbing trade.
- 5. Operating a variety of light and heavy equipment including jackhammers, hand and power tools, backhoes, skip loaders and trench diggers.
- 6. Working cooperatively with others.
- 7. Understanding and following oral and written directions.

- 8. Reading and interpreting blueprints, shop drawings, diagrams and specifications.
- 9. Meeting schedules and time lines.
- 10. Maintaining routine records.
- 11. Learning and applying laws, rules and regulations involved in assigned activities.
- 12. Maintaining sensitivity to and understanding of the diverse academic, socioeconomic, cultural, disability, gender identity, sexual orientation, and ethnic backgrounds of community college students, faculty, and staff.
- 13. Establishing and maintaining effective working relationships with all those encountered in the course of work.

WORKING CONDITIONS.

Environmental Conditions: The employee regularly works in outside weather conditions, near moving mechanical parts, and on slippery and uneven surfaces and is frequently exposed to fumes or airborne particles, toxic or caustic chemicals, and risk of electrical shock. The noise level in the work environment is frequently loud.

Physical Conditions: Essential and marginal functions may require physical fitness requirements necessary to perform the job functions with or without accommodation, such as the ability to use hands to repetitively finger, handle, feel or operate objects, tools or controls, to climb and work up to heights of 100 feet, to stoop, kneel, crouch or crawl, and to regularly lift and/or move up to 50 pounds and occasionally up to 75 pounds. Requires operation of District vehicles.

TERMS OF EMPLOYMENT.

The duration of any fully restricted funded position in this classification is dependent upon the continuation of funding.
