


#### Advance Medical Philosophy


# When to use Expert Medical Opinion

- Any confusing or unclear situation
- Second opinion for surgery or other treatment
- Behavioral health concerns
- Need help accessing medical resources
- Any cancer diagnosis or suspicion of cancer

#### **Expert Behavioral Care**

Behavioral Health is inextricably linked to Physical Health

One of the biggest barriers to individuals seeking out care is the stigma associated with mental illness

#### Member Story

A pre-adolescent female with multiple medical problems including severe developmental delay, cerebral palsy and scoliosis. Scoliosis surgery has been recommended. The family not sure surgery the best thing for their daughter and they are concerned it will cause more harm than good. They requested an Expert Medical Opinion for information about the risks/benefits of this surgery for their daughter.



The expert recommended not pursuing surgery as scheduled due to the patient's relatively young age and skeletal immaturity. He noted that the scoliosis is not likely causing the patient's pain and that the surgery would likely not change her pain picture.


