MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT AND THE PALOMAR FACULTY FEDERATION

This Memorandum of Understanding ("MOU") is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the PALOMAR FACULTY FEDERATION ("PFF"), collectively "the parties" and is in relation to Article 12: Department Chairs/Directors.

The parties agree that beginning in January 2021 (for the 21/22 academic year), the recalculation of department chair release time by the Instruction office using the matrix in 12.8 will occur in January of each academic year (using data from the previous spring and fall semesters), with notification of any changes communicated to the affected department chairs no later than February of each academic year, with changes to take effect August 1 of each academic year.

The language in 12.8 will be adjusted accordingly in subsequent contracts.
