MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT AND THE PALOMAR FACULTY FEDERATION

October 2, 2020

This Memorandum of Understanding (MOU) is made and entered into this October 2, 2020, between the Palomar Community College District ("District") and the Palomar Faculty Federation ("PFF") collectively ("the parties").

The purpose of this MOU is to assign 20% release time or equivalent stipend through June 30, 2021 to Candace Rose for work associated with the institutionalization of Credit for Prior Learning (CPL).

The 20% release time/stipend is in addition to that which may be granted by the Faculty Senate for a portion of the work to be done this year. The cost will be paid out of Guided Pathway funds.

The work for CPL was begun with grant funding made available for 2019-2020. Palomar College is required to be in compliance with the state-issued requirements of CPL by December 2020 and will require an additional semester to institutionalize fully the practices by creating and documenting ongoing processes and implementation.

This MOU is subject to approval and ratification by the Governing Board of Trustees.
