MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT & THE PALOMAR FACULTY FEDERATION

This Memorandum of Understanding ("MOU") is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the PALOMAR FACULTY FEDERATION ("PFF"), collectively "the parties" and is in relation to Article 8- Class Maximums.

Due to the extension of campus closures and online scheduling related to COVID-19, the parties agree to extend the terms of the MOU first signed on 4/21/20 and extended on 10/1/20 to cover the duration of the enforced campus closures through Spring 2022:

The parties agree to a temporary reduction in class maximums to 42 for those classes that are usually offered face-to-face with caps of more than 42. This reduction is optional, and departments can make the determination whether or not they wish to reduce their class caps to 42. All permanent changes to class caps will go through the typical class cap negotiation process.
