The parties agree that during the Fall 2021 and Spring 2022 semesters Richard Carr, part-time faculty, will receive 10 hours per week (non-instructional rate) of stipend for Umoja coordination ancillary duties and during the Fall 2021, Spring 2022, Fall 2022, and Spring 2023 semesters Sonia Gutierrez, part-time faculty, will receive 10 hours per week (non-instructional rate) of stipend for Puente coordination ancillary duties, as outlined in the respective grants/agreements.
