MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT AND THE COUNCIL OF CLASSIFIED EMPLOYEES (CCE/AFT LOCAL #4522)

This Memorandum of Understanding ("MOU") is entered into by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the COUNCIL OF CLASSIFIED EMPLOYEES ("CCE"), collectively "the parties".

The California Code of Regulations, Title 8, section 3385(a) states that, "Appropriate foot protection shall be required for employees who are exposed to foot injuries from electrical hazards, hot, corrosive, poisonous substances, falling objects, crushing or penetrating actions, which may cause injuries or who are required to work in abnormally wet locations"

Bargaining unit members who, as determined by the District and in accordance with OSHA Regulation 1910.136, are required to wear steel toe footwear shall be entitled to reimbursement for up to \$145 per fiscal year. The bargaining unit member shall submit their receipt for reimbursement within 45 days of purchase.
