



**MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (“MOU”) is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT (“District”) and the PALOMAR FACULTY FEDERATION (“PFF”), collectively “the parties” and is in relation to Article 16- Benefits.

As an extension of the MOU signed 11/10/21, and in an effort to minimize the impacts related to the COVID-19 pandemic for the Spring 2022 semester, the District will waive the 45% load requirement for part-time faculty members as outlined in 16.10.5 who participated in the medical insurance plan during the Fall 2021 semester.


