**MEMORANDUM OF UNDERSTANDING
BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT &
THE PALOMAR FACULTY FEDERATION**

This Memorandum of Understanding (“MOU”) is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT (“District”) and the PALOMAR FACULTY FEDERATION (“PFF”), collectively “the parties” and is in relation to Appendix F: Extra Duty Stipend/Reassignment Salary Schedule.

The position of Tenure and Evaluations Review Board (TERB) Coordinator requires a distinct and significant learning curve in order to ensure the continuation of appropriate and compliant evaluations, especially during the transition between coordinators. Kelly Falcone has been appointed by PFF and the Superintendent/President as TERB Coordinator, starting June 1, 2022. To provide for training of the incoming TERB Coordinator during Summer 2022, Lawrence Hamilton Lawson, the outgoing TERB Coordinator, will receive a one-time stipend paying for fifteen (15) hours of training at Hamilton Lawson’s non-instructional rate.
