MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT & THE PALOMAR FACULTY FEDERATION

This Memorandum of Understanding ("MOU") is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the PALOMAR FACULTY FEDERATION ("PFF"), collectively "the parties."

The purpose of this MOU is to compensate one qualified faculty member to maintain the Palomar Pathways Mapper Program. The faculty member will be jointly appointed by the District and the Faculty Senate. The assignment would be paid through an NOHE at their non-instructional hourly rate, not to exceed 100 hours per calendar year assuming an average of 2 hours per week. Additional hours may be approved in advance, by the Dean of Student Success, Equity, and Counseling. This is a 12-month assignment.
