- Industry collaboration including sitting on industry committees and boards
- Planning and hosting executive committee meetings and advisory board meetings
- Student inquiries--emails and phone calls with interested and current students
- Grant application and management such as Perkins and Strong Workforce
- Program Review & Planning (PRP) development
- Hiring committees for other disciplines or departments
- Coordinating water lab installation
- Preparation of new courses and course changes

The parties agree to revisit the above reassigned time during negotiations for the 2022-2025 CBA.
