

Tentative Agreement Between The Palomar College Council of Classified Employees CFT/AFT Local #4522 (CCE) And The Palomar Community College District (District) For The 2021-2022 Reopener Negotiations

May 17, 2022

ARTICLE 25 – HEALTH AND SAFETY

25.8 Footwear Safety

- 25.8.1 Employees who, as determined by the District and in accordance with OSHA Regulation 1910.136, are required to wear steel toe footwear shall be entitled to reimbursement for up to \$145 per fiscal year. The employees shall submit their receipt for reimbursement within 45 days of purchase. Reimbursement shall be provided to the employee no later 20 days from the date of their receipt submission.
- 25.8.2 Employees who, have determined that they need specific safety footwear to safely perform their job duties and whose immediate supervisor has concurred, shall be entitled to reimbursement up to \$145 per fiscal year. The employees shall submit their receipt for reimbursement within 45 days of purchase. Reimbursement shall be provided to the employee no later 20 days from the date of their receipt submission. All requests and approvals must be based on relevant statutory requirements (e.g., CalOSHA).
