MEMORANDUM OF UNDERSTANDING BETWEEN THE PALOMAR COMMUNITY COLLEGE DISTRICT & THE PALOMAR FACULTY FEDERATION

This Memorandum of Understanding ("MOU") is entered by and between the PALOMAR COMMUNITY COLLEGE DISTRICT ("District") and the PALOMAR FACULTY FEDERATION ("PFF"), collectively "the parties."

The purpose of this MOU is to assign 100% reassigned time for the Spring 2023 semester to Diane Studinka for an administrative special project to advance and oversee instructional division priorities in coordination with the Vice President for Instruction and the Superintendent/President.

During this time period, per her own agreement, Dr. Studinka will not be covered by the PFF/PCCD Collective Bargaining Agreement but will retain her faculty retreat rights.

The employee's assignment will begin on January 23, 2023 and will continue through June 30, 2023. This will provide the employee with a full year of service credit (12 months) for the 2022-2023 year. Due to the nature of the administrative special project, the employee will be compensated at the rate published on the administrative salary schedule grade 75 for these duties and will maintain her current level of District provided benefits. On July 1, 2023, the employee will revert to her 10-month faculty position unless hired into another District role.

This MOU is non-precedent setting.
