## Purpose of the HRS Planning Council

Dr. Norman asked members to share their expectations for the purpose of the HRS Planning Council; what is the function beyond sharing information. She commented on the importance of becoming goal oriented, creating a stronger voice, and connecting HRSPC goals to institutional goals and objectives.

S. Cohen said a draft of the Staffing Plan was created last year and presented at SPC. An overview of the (draft) Plan will be shared with HRSPC members at an upcoming meeting. Dr. Norman said she plans to meet with constituent group leaders to gather input regarding hiring and she will share the information with the HRSPC. The HRSPC will also be instrumental in the annual review of the Staffing Plan. There was a question regarding staffing for the new North and South Centers. Dr. Norman explained work is being done to expedite the hiring process, including an internal transfer process. The intent is to have all the newly hired employees approved at the May Governing Board meeting. Employees hired to work at either of the new Centers will first be trained and receive mentorship working at the main San Marcos campus. (III.A.9)
