The RTV program saw an increase in enrolloments in Fall 2007 and the program continues to focus on student retention and learning with improved scheduling and course offerings with the goal of increasing total student enrollments in the program. Our success rate continues to be above 70% and the retention rate is consistently in the 90% range over the last several years of data tracking. Over the past thirty years, the RTV program has provided students a unique mix of hands-on training with a solid educational background to compete in the highly competitive field of broadcast TV and radio. Our graduates are employed world wide, have won numerous student emmys and the RTV programs' reputation is well regarded in the broadcast industry.

Our 2nd priority is technology upgrades for Apple Mac Pro computers for video editing, news and production classes.
