#### \*2. Data Analysis (restate or summarize the data analysis from the PRP):

MCS course offerings from the same period show a 100% increase overall, with an 82% increase resulting in expanded course offerings starting in Fall 2006 with Asian American Studies, Middle East Studies, and Islam course offerings. Asian and Middle East studies have seen significant growth, with additional potential within the department as well as cross-listing potential. The growth of Middle East courses is especially significant as in the early stages we faced considerable negative comments from the community as fears and misinformation regarding Middle Eastern cultures, and Muslims in particular prevailed. Thanks to the support of Dean vernoy as well as the chair of the Religious Studies Program, we remained strong, cross-listed with the Religious Studies Program, and as a result last Fall enrollment was 250% over the prior year. This indicates a need for a full-time faculty position in the Multicultural Studies Program and a public relations coordinator, America Barcelo-Feldman, to oversee the various functions for the following areas in publicity and outreach: 10% AS, 10% JS, 10% CS, 70% MCS (10% Cine Club, 20% Honors Program, and 40% MCS). The MCS faculty have greatly contributed by their activities. For example, Professor Gloria Gonzales has developed an exciting new course on Asia which focuses on India, China, and Japan which are the leading nations of the future: Dr. Sharon Allen recently completed her PhD in Philosophy and is publishing her work in an anthology on the concepts of borders; John Valdez recently completed a sabbatical in the fall 2008 to China and India and also participated in his third invitational Oxford Round Table in 2009 and presented his paper on the subject of Cesar Chavez and his contributions to social justice, and Christine Moore also participated in this invitational Oxford Round Table in 2009 and presented her paper on Sor Juana Inez de la Cruz. Another program that is being developed is the Honors Program which is a vital program to institute greater understanding of crucial issues that we experience in our society concerning immigration, relations between Muslims and Jews, and issues concerning social orientation and gender. In addition, the Multicultural Studies Department is in the process of developing an HSI grant that was recently approved several years ago and in which the MEChA and Encuentros student organizations along with the MCS Department are promoting the involvement, mentorship, and success of first-generation college students and will involve the disciplines of STEM (Science, Technology, Engineering, and Math).

#### \*3.a/b. Describe your goal (priority) based on data analysis from the PRP:

The previous goal listed by the chair regarding the new World Cultures certificate having a positive impact in the area of Multicultural Studies was insufficient. In this program review for 2010, I wish to reinforce the great necessity to provide and prepare all students for a pluralistic society whose members can appreciate and study the many contributions and values of this world's culturally diverse groups so that we can foster a climate in which better understanding and relationships can more easily and naturally take place. Students overwhelmingly provide the basis of this conclusion through their comments to the MCS faculty regarding the classes in which they state that the MCS courses are very enriching and students can address stereotypes, prejudices, racial and cultural tensions in a supportive and learning forum. Students indicate through their discussions and writings the great value of the discipline of Multicultural Studies. This is why we request a full-time position as well as the public relations coordinator for the MCS program, as one of our full-time faculty in the MCS program is nearing retirement and the increase of student enrollment calls for another full-time position. With the new position comes an entire array of expertise in the knowledge of history, culture, and diversity that can help to bridge the gaps in our students' education and prepare for a new generation in an increasingly international and global society.
