PART 2: PROGRAM REFLECTION

1. Program Analysis:

Reflect upon and provide an analysis of your summary data.

Enrollment, WSCH, and FTE: Though enrollment in the BMGT discipline slightly increased in 2016 to 188 students and averages 233 (2011 - 2106), it has been an area that is in decline. This trend is understood and is why this discipline will be folded in as an emphasis area in BUS going forward. WSCH/FTEF is 430.57 - higher than the previous 3 years. Our fill rate of 66.20% is higher than previous years but still lower than it should be.

Achievement: Overall success and retention rates are low (43.3% and 86.6%, respectively). We know why this is the case: the curriculum needs to be updated with a focus on entrepreneurship and the discipline needs to become a focus area within Business.

Awards: There were 8 degrees awarded in 2015-2016, consistent with previous years. In addition, there were 8 certificates (18+ units), also consistent with previous years.

2. Standards:

We have two proud moments/achievements. One is the creation and successful running of the Business Club, which encourages business students to learn about and launch their own small businesses. The second is the launch of a new course, BUS 153 - Small Business Entrepreneurship. This course is an updated version of BMGT 105 - Small Business Management -with a focus on the entrepreneurship skills and mindset needed to be successful in small business start ups.

This year, we are working to drive success of new courses and re-design the Business Administration degree to include management and entrepreneurship as a focus area.

At the program level, we have decided to deactivate the BMGT discipline and fold it in as an area of emphasis in the BUS (Business Administration) degree.
