



Student Headcount and FTES





Student Race/Ethnicity






Full/Part-time Status of Students – TO DO



Placement of First-time Students















Summary

- Slight increase in headcount and the move to a compressed calendar provided a "bump" in FTES and WSCH/FTEF over the previous fall
- Majority of courses offered are transfer-level courses
- One third of the courses offered fall into vocational education and about 10% of course offerings are distance education

Institution-Set Standards

- Required to have them
 - Identified level of performance determined by the institution to be <u>acceptable</u>
 - Used to assess both institutional and programmatic performance
 - Assessed for "reasonableness" and "effectiveness" by external peer evaluators
- Not a goal, but they have to be reasonable. We cannot set standards based on the "minimum" value over time unless we have some logic to support
- We will be required on our mid-term report to establish "stretch" or aspirational goals.



Completion Rate Peer Grouping

- Updated peer groups for the Completion Scorecard
- Diverse academic and economic environments of students are important factors affecting individual student achievements and overall institutional performance.
- Identified uncontrollable factors, or predictor variables, associated with completion. ("Environmental Factors")
- Using regression modeling and cluster analysis, identified colleges that closely resembled each other in terms of the uncontrollable factors.
