

Educational & Facilities Vision Plan 2035

EDUCATIONAL VISION PLAN

- Provides direction for community college programs and services to meet the needs of current and future students, regional employers, and the communities served by the college
- Provides direction for resource allocations, facilities and technology plans, and staffing

FACILITIES VISION PLAN

Ensures that the College's facilities support the Educational Vision Plan:

- Facilities space
- Landscaping and outdoor space
- Campus-wide systems
- Sustainable operations + culture

- Equity and Inclusion
- Internal & external stakeholder engagement of all educational sites
- Sensitivity to internal governance structure
- Accountability (on time & within approved fees)




EFVP Timeline and Development Rocess



- Steward development of the EFVP 2035
- Review internal and external data, both quantitative and qualitative, to gain an
 understanding of the community and our current and future students
- Review Develop planning assumptions, goals, and recommendations for
 establishing the desired capacity, programmatic focus, student services, and
 enrollments at each district site, as well as the role of each site as a resource to its
 local community
- Use EVP results to inform FVP
