

#### THE HOWARD BRUBECK THEATRE

The Performing Arts Theatre on Palomar College campus, constructed in 1965, has been given a new name by the Governing Board of the College.

Since August 1992 it is the Howard Brubeck Theatre, honoring Howard for the many years he has served the college and community teaching music and administering, promoting and supporting the fine arts.

From 1953 he was a music instructor; often it seemed that he was the music department, until Jim Weld joined us. He later became Dean of Humanities Division, a position he held until his retirement in 1978.

Since retirement he has been very active in advising and promoting the Escondido Civic Center, and has also spent much time with the activities of the Palomar College Foundation. Much of his recent interest has been in leading the development of the Palomar College Retirees' Association, now in it's second year. As you know, he has been President of PACRA for these two years.

If you think these tasks have taken all of his time, you will have overlooked the many days and weeks he has spent with family and friends.

On August 21 he was honored at a luncheon with the faculty, staff and guests, followed by a ceremony in the theatre at which, after speeches and music, he was presented by the College with a bronze plaque commemorating the renaming. We're proud the College community has appreciated his service by giving his name to the theatre.

# FROM PRESIDENT BOGGS

President George R. Boggs reports that the final budget for Palomar College, passed by the Governing Board in advance of the State budget (which was not signed until Sept. 2, 1992), turned out to be quite accurate. Consequently, Boggs emphasized, there will be no reduction in class offerings or services to students, or staff layoffs during the spring semester. Nevertheless, the new state budget caused community college funding to suffer, and mandated that student fees be increased.

Effective January 1, 1993, and continuing through January 1, 1995, fees will be \$10 per unit with no maximum. This compares to current fees of \$6 per unit with a maximum \$60 per semester charge. The new fee schedule also provides that students who already have a baccalaureate degree will pay \$50 per unit unless they can prove they are dislocated workers, displaced homemakers, or recipients of public assistance. This provision continues through January 1, 1996.

Even with increased fees, California Community Colleges remain a bargain. He pointed out that California taxpayers pay 17% less in state and local taxes for community colleges than the national median. Student fees as assessed after January 1, 1993, will be the lowest community college fees in the nation.

The 1992-93 budget for Palomar is \$46,487,000.00, compared to last year's total of \$45,288,944.00. These budget figures were provided by Assistant Superintendent Mike Gregoryk's office.

The Communications Committee has identified its role with PACRA as that of helping form and maintain a sense of community among its members.

The Committee will seek to carry out its role by periodically publishing a newsletter to be called The PACRA Pacer.

#### WHERE ARE OUR MEMBERS?

#### **CEREMONIES**

Early in this century a familiar name in classical music and international affairs was Ignance Paderewski, composer, concert pianist, and first prime minister of Poland after World War I. He played many concerts in Europe and America, and died in the United States in 1941.

Because of the war his body could not be returned to Poland for burial, but was placed in Arlington Cemetery by order of President Franklin D. Roosevelt, until "Poland shall be free".

In June 1992, arrangements were made by the United States and Poland to return the body to his homeland with proper ceremonies. Mr. C. J. Paderewski, architect for all new buildings on Palomar's campus from 1947 to 1983, was the nearest living relative of the pianist, and was asked to give formal permission to remove the body. Pat and Maxine are honorary charter members of PACRA.

The Offices of the President of the United States and Veteran's Affairs arranged appropriate ceremonies at Andrew's Air Force Base. Mr. and Mrs. C. J. Paderewski were guests of the United States Government, and accompanied the group to Warsaw in Air Force Two, where other ceremonies were held. President Bush flew to Warsaw and participated in the final event. Pat and Maxine, after several days of celebration, returned to the United States in the President's plane.
