Dear Colleagues,

It is with profound sadness and a heavy heart that we announce the passing of Megan (Dunbar) O'Brien, one of our exceptional part-time instructors in psychology. Megan passed away on September 2, 2022 after a nearly 3-year battle with breast cancer. She was incredibly strong in her fight. Megan is survived by her husband, Matt O'Brien (a full-time psychology professor at Palomar College), and their 2 beautiful children.

Megan began teaching psychology at Palomar College in 2013. She was a proud alumna of Palomar College and loved that she could impact the lives of students where her own academic journey began. She also taught upper-division psychology courses in industrial organization and group dynamics at California State University, San Marcos. At both institutions, she developed a reputation as a passionate, dedicated, and caring instructor. She mentored her students and helped them develop the skills necessary to succeed not just in her class but in future courses and in life as well. It was evident that her students loved her, describing Megan as patient, friendly, easy to approach, and always willing to help," "an amazing teacher," "has a passion for what she's teaching," "so kind," "fun," and that they "love learning from her. They, and we, were incredibly lucky to have her as part of our Palomar family.

Beyond being an exemplary educator, Megan was a devoted wife, mother, sister, colleague, and friend. She was strong, resilient, a bright light, filled with grace, and a role model to her kids and to all on how to live, love, and face insurmountable challenges. She had an infectious smile and was always there for whomever needed her, even while undergoing treatment. She loved spending time with her children and they loved being with her—crafting, going to the zoo and Sea World, gardening, baking, the list goes on and on. She was also a compassionate and supportive wife to Matt, spending their days talking about their kids, discussing teaching, watching true crime shows, traveling, and trying new restaurants. She was a loyal friend and listener to anyone who needed it. She was a giver of her time, knowledge, and love. Her absence leaves a void in all who knew her.
