I. <u>CALL TO ORDER/INTRODUCTION</u>

Chief Moore opens and will be facilitating the meeting. No agenda for this meeting.

DISCUSSION ITEM(S)-OLD BUSINESS

Chief Moore has a few announcements:

Lot 15 as a restricted lot, currently working with signage for 12 parking spaces for Performing Arts parking only.

Digital permit/contactless permit, as parking enforcement will continued through the spring semester.

Review of Incident Report: Fire: Sgt. Lynch, incident commander, about 11 acres burned. Unsure of origin of fire, successfully evacuated ECE department. Parents were contacted.

DISCUSSION ITEM(S) - NEW BUSINESS

- SGT. LYNCH: Continue of Incident Report of Fire: Advised that lot 1 was the stage area/command post for the Fire crew and Police.
- CHIEF MOORE: 150 units gathered to assist, and one unit stayed overnight on campus.
- Upgrades are needed for the cameras for the dispatch center. A camera is needed for the Theatre department.
- Facilities Department assisted by setting up tents. Most of the campus self-evacuated.
- THOMAS DAILY: What was the estimated damage done from the fire?
- CHIEF MOORE: Advised that Derrick Johnson is working on the report on estimated damage. Around 6:40pm the fire was contained.
- SGT. LYNCH/LISA CASAS: Start of fire was around 12:20pm/1pm. Sgt. Lynch will contact the ECE department to follow up on the incident.
- CHIEF MOORE: Police Department worked a 12-hour shift during the fire incident.
- Working on Police Reform-DOJ Data on traffic stops updates with Stg. Lynch and Dispatch Coordinator Nieves Suarez. Updated Policy to publish online.
- Wellness App for officers (Cordico): counseling, meditation, nutrition-Public Safety ready to launch app in the next week or so. (updates will be in next agenda's meeting).
- LISA CASAS: Expressed her gratitude towards the officers and CSOs that assisted during the fire incident.
- CHIEF MOORE: Will work on the ECE department having radios for future incidents. Requested to have access to direct extensions when communicated with the ECE department.
- THOMAS DAILY: Will lot 15 and 12 have visitor parking spaces? Will permits be required for visitors? Why is there no charge for parking when a building is being rented for an event?
- CHIEF MOORE: Visitors will require permits while parking in visitor spaces. Facilities will start charging parking spaces for those that require parking for their events.
- THOMAS DAILY: Will like to keep on fighting to have the committee active. Wayne Hooper agrees.
- WAYNE HOOPER: Any ideas of when students will return to campus? Zoom benefits allows students to stay in class rather to be waitlisted.
- CHIEF MOORE: Unsured on whether students will be returning to campus or be placed on a hybrid schedule. Maybe outdoor classes will be offered. The Rancho Bernardo and Fallbrook campuses will remain closed.
