## **AB 481 Compliance Inventory**

**Model:** LMT 40mm Less-Lethal Launcher 1425

Quantity: 1

Lifespan: Approximately 15 years but varies according to usage

**Description:** Manufactured exclusively for Defense Technology, the 40LMTS is a tactical single shot launcher that features an expandable Rogers Super Stoc and an adjustable Integrated Front Grip (IFG) with light rail. The ambidextrous Lateral Sling Mount (LSM) and QD mounting systems allow both a single and two-point sling attachment. The 40LMTS will fire standard 40mm less lethal ammunition, up to 4.8inches in cartridge length. The Picatinny Rail Mounting System will accept a wide array of enhanced optics/sighting systems.

**Purpose:** 40MM Launchers and Munitions are utilized by Department personnel as a less-lethal tool to deploy less-lethal impact munitions. Lawful application of force delivered with the intent to subdue or render non-threatening. The less lethal munitions may be used as an option to deescalate a potentially dangerous/deadly situation, with a reduced potential for death or serious injury to all persons involved. It is accepted that the probability exists for bodily harm to occur. However, it must also be accepted that the application of such force may be the only alternative to using lethal force to stop the subject's actions.

**Training:** California Peace Officer Standards and Training Certified course and continual inservice training. Additionally, all officers that operate any Less Lethal Devices are required to pass a qualification course of instruction by the department.

**Authorized Use:** Situations where the deployment of less-lethal impact or chemical munitions are authorized. Only Officers that are POST certified in the use of the Less-lethal Launchers are authorized to deploy them in the field.

**Legal and Procedural Rules:** The Department will only utilize less-lethal devices in accordance with State law, Federal law and Department Policy.

Model: Remington 870 Less-Lethal Shotgun w/orange synthetic stock

Lifespan: Approximately 20 years but varies according to usage.

**Description:** The Remington Model 870 Pump Shotgun is a reliable 12-gauge with double-action bars for smooth pump operation. A steel lined/grooved fore-end provides a stronger grip, while the Flexitab feeding system provides positive and easier cycling. The less-lethal application shotgun has a blaze orange synthetic Speed Feed stock and fore-end for the instant recognition required.

**Purpose:** Lawful application of force delivered with the intent to subdue or render non-threatening. The less-lethal munitions may be used as an option to de-escalate a potentially dangerous/deadly situation, with a reduced potential for death or serious injury to all persons involved. It is accepted that the probability exists for bodily harm to occur. However, it must also be accepted that the application of such force may be the only alternative to using lethal force to stop the subject's actions.

**Training:** Prior to deploying the Less-Lethal Shotgun, members must complete a POST certified course in the operation of Less-Lethal Shotguns. Additionally, all members that operate any Less-Lethal Devices are required to pass a qualification course of instruction according to department policy.

**Authorized Use:** Situations when the deployment of less-lethal impact or munitions are authorized include, but are not limited to self-destructive, dangerous, and/or combative individuals.

Fiscal Impact: Initial Cost per Less-Lethal Shotgun - \$600 each
