#### A LETTER FROM THE COMMITTEE CHAIR

# Dear Community Member:

On November 7, 2006, voters in the Palomar Community College District approved a \$694 million facilities bond measure (Proposition M) under the rules established by Prop 39. This measure supports the District's Master Plan 2022, which was published in August 2003. More than 57% of the voters supported Proposition M, and saw it as an investment in their community college. Under the rules of Prop 39, a citizen's oversight committee (ICOC) was established September 26, 2006.

We are pleased to present our 2007-2008 Annual Report covering the period from May 2, 2007 to June 30, 2008, to the Palomar College Governing Board. The Annual Report is available to District residents, in fulfillment of the role of the ICOC, as specified by law, and to provide a report on the activities accomplished this past 18 months from that investment.

The Committee's primary responsibilities are to:

- Review expenditures to ensure that bond proceeds are expended only for the purposes set forth in Proposition M.
- Provide a statement indicating whether the district is in compliance with bond requirements.
- Present to the District's Governing Board an annual report summarizing the Committee's proceedings and activities for the preceding year.

The Committee reports that, to the best of its knowledge, Palomar Community College District is in full compliance with the responsibilities as described in Article XIIIA of the California State Constitution. With this report, the ICOC members assure the community that Proposition M bond expenditures have been issued properly, and only for projects identified in the bond measure and that no measures or monies were used unlawfully for teacher and administration salaries.

It has been my pleasure to serve as ICOC Chair and to work closely with the committee and the District staff. I am proud of the work we have accomplished thus far on behalf of the community to "Maintain and Modernize Palomar College." We look forward to continuing the positive work your investment has provided as Palomar College continues to serve its community.

#### **ABOUT PROPOSITION M**

On November 7, 2006, voters in the District's service area approved Proposition M, a \$694 million facilities bond measure, which enables the District to:

- Upgrade nursing and emergency medical career training labs
- Modernize outdated science, computer and job training labs/equipment
- Upgrade electrical and technology infrastructure
- Repair/replace deteriorated roofs, plumbing, lighting, heating and ventilation systems
- Improve energy efficiency
- Modernize/replace outdated classrooms and student support facilities
- Complete safety upgrades to College buildings and grounds

The Independent Citizens' Oversight Committee monitors the expenditure of funds from the Proposition M General Obligation Bond to ensure that bond revenues are expended only for the purposes described and that no bond funds are used for any faculty or administrative salaries or other operating expenses. Proposition M was authorized pursuant to paragraph (3) of subdivision (b) of Section 1 of Article XIIIA of the California Constitution, and subdivision (b) of Section 18 of Article XVI of the California Constitution in accordance with the requirements of the Strict Accountability in Local School Construction Bond Act of 2000 (Prop 39).

# **COMMITTEE ACTIVITY SUMMARY**

The Palomar College Governing Board approved members to the ICOC on May 8, 2007. The Committee met five times in fiscal year 2007-2008. Proceedings of these meetings included:

- Organization meeting to include appointment of Chair; review bylaws and roles and responsibilities of ICOC
- Development of ICOC Website -- http://www.palomar.edu/propm/icoc/
- Review of financial reports
- Review of construction projects

#### **PROPOSITION M PROGRAM ACTIVITIES**

- Purchased an 84-acre parcel of land for the new Palomar College North Education Center (near the northeast corner of Highway 76 and Interstate 15).
- Conducted the required California Environmental Quality Act/Environmental Impact Report for the Palomar College North Education Center site.
- Augmented the new Natural Science Building, a State Capital Outlay Project, opened in fall 2007, for equipment and technology needs.
- Commenced the California Environmental Quality Act/Environmental Impact Report study process for the San Marcos campus.
- Submitted final plans and specifications to the Division of the State Architect for approval of the Health Sciences Building and the Multidisciplinary Instructional Building (MIB).
- Purchased and installed computers in student labs, and in faculty and staff offices.
- Coordinated District designer groups with architectural teams on the following projects: Multimedia Lab and Planetarium; Escondido Center North Wing retrofit; parking improvement plans; Industrial Technology Building; Howard Brubeck Theater addition and remodel; baseball field relocation; high-voltage infrastructure upgrade; and the A-Building emergency generator.
- Identified more than 100 facilities improvement and special projects, which are in various stages of completion.

#### **LEVERAGING PROP M FUNDS**

- Received a San Diego Gas & Electric "Savings by Design" award for energy efficiency -- the largest award to an educational institution in San Diego County (\$131.5K).
- Committed to design all buildings to LEED standards through sustainable design, and recycling and sale of materials no longer usable to the District.
- Secured approval of State Capital Outlay funds for the Library/ Learning Resource Center project.
- Redistributed computers replaced throughout the District and donated 200 "gently used" computers to Vista High School.

#### **SERIES A BOND ISSUANCE**

In May 2007, the Palomar Community College District issued Series A bonds in the amount of \$160 million.

#### **REVIEW OF EXPENDITURES**

The firm of Vicenti Lloyd & Stutzman LLP, Certified Public Accountants conducted the Financial and Performance Audit for proceeds and use of general obligation bonds for the fiscal year ended June 30, 2008, as required by Proposition 39. The results of the procedure performed indicated that expenditures were made for authorized bond projects.

The finding of no discrepancies validates the success of internal controls established by the Palomar College Finance and Administrative Services Division and implemented by staff.



# PROP M PROGRAM (TOTAL BOND AUTHORIZATION - \$694,000.000)


# **Bond Expenditures**

Expenditures for May 2, 2007 - June 30, 2008




