What is Palomar Promise:


Promise offers up to two years of free tuition (fall & spring), textbook assistance, and specialized academic, career planning, and support services –

Regardless of family's income!

Requirements:

- File 2025-2026 FAFSA or Dream Act DO NOT NEED TO QUALIFY!
- California resident or eligible exempt group (AB540 or military)
- 12 units each semester (possible DRC exemptions)
- 2.0 GPA

- If message: Not eligible, for First Time College students, contact Promise to clear you. You are a graduating high school senior and took classes while in high school.
- Application: 4 mouse clicks
- Promise Checklist will appear.
 - ✓ Make sure CA residency is checked.
 - ✓ FAFSA/Dream Act gets a check several weeks after you file your FAFSA or Dream Act.

- Palomar annual Scholarship season May 5, 2025 August 15, 2025.




