Jayne reported that she is still working with Ken Jay and Chris Wick on the Facilities Department's Environmental Health & Safety Medical Injury Report form.

5. **ASG**

Josh reported that today is World Aids Day. It is an opportunity to bring people together to raise awareness for HIV.

6. **Environmental Health & Safety**

John reported that for the month of November 2010, the following activities occurred:

- P-32 slip/trip hazard repaired.
- Curb cut at the main entrance to the Child Development Center will be repaired during the Holiday/Semester Break.
- NS-231 leak/slip hazard reported.
- A vendor fell on 11/17/2010 and 9-1-1 was called to transport him to the hospital (vendor's workers comp covers him for this incident).
- Library evacuation chairs finally installed (they have been waiting five years).
 - Katherine Gannett will required training in their use
 - Signage needs to be made indicating their location.

- ♦ EHS needs to work with the Disability Resource Center in case of a power outage.
- There is one evacuation chair in the new Health Sciences Building located inside a cabinet.
- An ADA scooter was provided to a district employee; while another scooter request is in-progress.
- Campus Police hosted a "Conflict Resolution" workshop with the Counseling Department. John reported that Tony Cruz is trying to tie these types of workshop in with emergency response and the Cleary Report.
- Hazardous Materials Pickup and One Disposal

John reported that the San Marcos Fire Department (SMFD) is conducting a 'Joint Hazardous Materials Training Exercise' with the Palomar College Police Department (PCPD) on Wednesday, January 12-14, 2011, from 9:00 a.m. to 12:30 p.m. at the Swimming Pool and Lots 3 and 3B. The exercise is designed to prepare for a coordinated effort between local agencies in the event of a hazardous materials spill.

Agencies participating are SMFD, PCPD, San Diego County Department of Environmental Health (DEH) and the Camp Pendleton Hazardous Materials Incident Response Team (HIRT) Unit. The Palomar College Facilities department will also participate in the event.

C. Action Item/Second Reading

1. Emergency Response Group recommendations

Jayne indicated that she was unclear on Herman Lee's element of mass notification?

With the proposed upgrade to Parking Lots 3 and 5, it is hoped that three phones will be installed in these lots and be available beginning August 2011 depending on budget updates.

John and Kelley recommended that a short-wave radio be added to the Emergency Response Recommendations listing (CSUSM has one). This radio would be utilized primarily when a cellular tower goes down.

Kelley reported that some items that were officially approved on this listing have already been completed and no action is required. Kelley asked that this item be tabled and brought forth in February 2011.
