- 1. Derrick Johnson presented issues with pedestrian crossing on campus. Pedestrian traffic is a concern at all campuses. Motion made to bring a third party consultant in for a pedestrian traffic study. For implementation it is recommended that pedestrian traffic concerns are addressed in the master plan. Derrick will consult with Dennis in that regard. Moved to first reading. Unanimously approved for second reading.
- 2. Open discussion on video expansion plan. Funding is needed for additional cameras and for staffing a position to monitor cameras.
- 3. Connie Sterling wants building evacuation drills and evacuation kits at Fallbrook and Rancho Bernardo.
- 4. Judy Harris is recommending 'Stop the Bleed" kits throughout campuses. Derrick will talk further with Chris Miller.
- 5. Moore discusses need of cameras at SU. Moore wants to shutdown elevators at NS to prevent unauthorized access to building over weekend. Derrick will discuss this with Kone and NS building dean.
