- Waste inventory/lab packs will be picked up after finals.
- Romic Environmental will be moving chemicals and specimens from the Chemistry Department and transporting them to the Natural Science Building.
- Air Pollution Control District Inspector made an unscheduled visit to check out the District's and Contractor's generators.
- Floor samples have been taken at the F-Building.
- Tom Plotts, Chief of Campus Police, is currently in the process of reviewing the District's Emergency Preparation Plan as new regulations have recently been implemented. Tom has met with Norma at the Escondido Center and will meet with Kelley shortly.
