Michelle Barton stated the Vision and Mission Statement and the Strategic Plan needs to be completed by May/June. Later this year, the Chancellor's Office will release guidelines for one complete plan. It is recommended that next year the Strategic Plan be a one-year bridge plan until the Chancellor's recommendations are released.

Ms. Barton reviewed the steps for Vision for Success and Strategic and Master Plan 2022 Development. She asked members to break into three groups to identify the work accomplished on the goals in the Strategic Plan 2019. Afterward the groups shared their results. (Attachment)

A spreadsheet was shown listing five existing Plans in columns with its objectives under each: Vision for Success, Strategic Plan 2019, SEM, Guided Pathways, and Equity Plan. The hope is to create a comprehensive plan that merges goals from all the plans. Ms. Barton led a discussion on our over-arching goals and key performance indicators throughout the plans. The Equity Plan, Technology Plan and Staffing Plan will need to connect into the goals as well. Ideas on how to organize the goals were shared, such as using VfS local goals or Guided Pathways as the Strategic Goals. The discussion will continue at the special meeting on February 22, 2019.

Michelle Barton reviewed data from Student Success Metrics Dashboard for Palomar College for the Five VfS Goals: Completion Degree and Certificates, Transfer, Unit Accumulation, Workforce, and Equity. 



Chancellor's Office Approved Certificates




Attained Vision Goal Completion






Median Income
