- The Palomar College Foundation increased its scholarship fund by more than \$200,000, bringing its scholarship total to \$1,556,000. The Performing Arts League contributed more then \$3,000 to support students.
- The Institutional Review Committee and the Faculty Senate approved a revised, expertisebased Institutional Review process to include student learning outcomes measurement.
- The U.S. Department of Education certified Palomar College as a Hispanic Serving Institution. The certification will provide access to significant grant funding to serve under-represented students. One such program is the GEAR UP partnership with local schools to encourage young people to aspire to attend college. More than half of the 3,264 students served by Gear Up in 2002-03 were Hispanic.

- The District joined a data-sharing consortium with several local high school districts to improve college readiness of high school graduates.
- Sixty students graduated with an Associate Degree in Nursing (ADN). Nursing students passed the National Council Licensure Examination (the final step to obtaining a nursing license) at a rate of 98.5 percent, as compared to an 83 percent statewide pass rate.
- Dental students passed the Registered Dental Assisting Exams at a rate of 81.3 percent, as compared to the statewide pass rate of 68.9 percent.
- The Police Academy graduated 70 students who are now certified by the California Commission on Peace Officer Standards and

Training. About 80 percent of these graduates are now working as peace officers in San Diego and Riverside Counties.

- The Fire Fighter Academy graduated 95 graduates, about 95 percent of whom are now working as firefighters in Southern California. The Fire Fighter In-service Training Program provided in-service to the 525 fire fighters working in North San Diego County fire departments.
- The Paramedic Program graduated 44 licensed paramedics who are all now working as paramedics in Southern California.
- The Palomar College football team ranked fourth in the nation, while our cheerleading team brought home a second-place trophy from the national championships. Our wrestling team earned a state championship, and our wide range of athletic teams for men and women won eight conference championships in 2002-03. Forty-one student-athletes transferred to four-year colleges with athletic scholarships.
- CalWORKs, a program to provide educational opportunities and job experiences to lowincome adult parents, served 1,136 students, nearly twice the previous year's total. More than 200 students in this program graduated from Palomar College and transferred to a four-year college.





- The Speech and Debate Team ranked 10th in the nation from among 85 schools that advanced to national-level competition. At the national level, the team received the Huffer-Goldman Interpreter's Theatre Award for outstanding theatre.
- At the San Diego County Fair, art students won 26 Best of Class and 13 Best of Show awards. Students in our Cabinet and Furniture Technology, Drafting, Design, Diesel and Automotive Technology programs also won numerous Best of Show and Best of Class awards. The student newspaper, Telescope, won two Best of Show awards.
- The student newspaper, Telescope, was one of only four in the state to receive the Pacesetter Award, the most prestigious award given by the Journalism Association of Community Colleges.
- Sarah Strause, Stephen Keller, and Tom Chambers competed against all San Diego weekly news writers and won first place for an education story or series from the San Diego Chapter of the Society of Professional Journalists. Several journalism students also won awards from the San Diego Press Club for feature and news stories, opinion pieces, and web site.
- Sally Serrin made the All-Academic California first team for California Community Colleges.








### Fall 2002 Enrollment by Ethnicity



• The newly-formed Government Affairs Committee led advocacy efforts including a regional news conference, student rallies, letter-writing campaigns, opinion editorials and a community advocacy task force. Direct results of these efforts were a reduction in mid-year cuts to Palomar College by \$1.3 million and a reduction in proposed cuts to Palomar's 2003-04 budget by \$3.1 million.

### Economic Impact on the Local Community:


According to the San Diego State University Office of Research and Service for Post-Secondary Education, Palomar College continues to generate a significant economic impact on the local community equal to that of a sizeable business enterprise. The College functions as an employer, consumer of goods and services, investor, landowner and builder.

Palomar College contributed \$135 million to local area wealth in 2001-02 through purchasing activity, payroll, Foundation expenditures, student financial aid, and indirectly through local businesses that provide goods and services to the College.

The College's economic activity also contributed to 7,618 jobs in the local community for 2001-02. Palomar employed 1,288 full-time-equivalent employees in 2001-02. Based on a conservative job-creation formula, SDSU researchers suggest that Palomar College also accounted for an additional 6,330 jobs in the local community – belonging to men and women who supply goods and services to the College.

Palomar contributed \$8.2 million to the local financial credit base in 2001-02 through employees' savings and checking deposits in local financial institutions which then loan to area residents and businesses.

- Master Plan 2022 will guide the District in developing educational programs and facilities to accommodate 17,500 new students. The plan, developed by a team of faculty, staff, administrators and students, supports highquality education and focuses on expanding the San Marcos campus as well as existing sites, establishing at least one new center in either the north or south portion of the District, and establishing at least one new campus in either the north or south portion of the District.
- The Student Center opened in June 2003.
- Final plans were submitted to the state for a high technology laboratory and classroom building. Construction is scheduled to begin in spring 2004.

During 2002-2003, the Palomar College Foundation total income was more than \$1.7 million. The Foundation holds one of the largest community college scholarship funds in California and manages and processes \$1.5 million in scholarships for Palomar College students each year. In 2002-03, the Foundation, along with the President's Associates and Lake San Marcos Friends of Palomar College, provided furniture and computers for the new Student Center, funded a study to assess the economic impact of Palomar College on the North San Diego County area, and sponsored several events designed to reach out to local high school students.

The Palomar College Foundation raises a significant portion of its funds through top-notch events such as the Lake San Marcos Friends of Palomar College Golf Tournament, the Palomar Goes! black-tie gala and the annual Wine & Dine event.
