This means your enrollment fees are due when you register in classes. Depending on when you enroll in classes, you may be dropped within 10 days of your registration if fees are not paid. To reestablish my coding I will need to fill this request out again with the Palomar Veterans Services Office.

_____ I will be responsible for paying Palomar College for any and all tuition and fees not covered by my VA education benefits (to include out of state tuition and fees).
